# Sales Tax Rules and Regulations Resale Certificates Effective July 1, 1996

To Our Customers:

In compliance with California State Sales and Use Tax Ruling NO. 68, it is necessary that we have from all customers a signed resale certificate, with their State sales Tax Permit Number to show that the merchandise has been purchased for resale.

The good faith of the seller will be questioned if he has knowledge of facts which gives rise to a reasonable inference that the purchaser does not intend to resell property, as for example, knowledge that a purchaser of particular merchandise is not engaged in the business of selling that kind of merchandise.

Under "Description of property to be purchased": there may appear:

Either an itemized list of particular property to be purchased for resale, or

A general description of the kind of property to be purchased for resale. Such certificate is good until revoked in writing. Please insert your *New State Sales Tax Permit Number* with your signature and address, *on the resale certificate* portion of this form and return it to us at once. Your cooperation is appreciated.
